*Village Manager Chris Brown* – Republic Waste does not offer that service.

*Chris Conroy, 560 South Hancock Street* – Will we be getting an update on the Water Taxi. I notice we had expenses this year but no revenue.

Dan Hokestra 160 4th Street - I represent The Concerned Citizens of Pentwater.

We want to thank the council members who did their due diligence on the issue of recreational marijuana storefronts in the Village. We have learned how the democratic process truly works for a citizen led ballot initiative. We also found that the Village, Township, and County Clerks have also learned through this process. No one we talked to had ever done this type of initiative. We were thanked for using this process because they learned along the way. The petition language has been approved by the Village, the signatures of voters have been verified by the Township, and lastly the ballot language has been approved by the Oceana County Election Commission. We were notified by the County Clerk's Office last week that everything is in order, and the Village of Pentwater will have the citizen led Initiative on the May General Election ballot regarding marijuana establishments. We want to thank the President, the Village Council, the Planning Commission, Village Attorney, and Village Manager for the time that they put into this local issue. I personally would like to express my gratitude to the members of our group that put time, money, and effort to make this happen for the betterment of our Village.

Karl Schrumpf, 214 South Wythe Street – I am a new resident in Pentwater. I was wondering if you sent out bids to have the leaves remove from an outside source.

Mary Temple, 560 South Hancock Street, #11 – Hope Council will be doing an exit interview with Keith Edwards. Could the channel dredging fit under the Infrastructure Bill.

Trustee Dave Bluhm – We will be meeting to talk about the shoring in the channel this month. I have been reaching out to stake holders including residents to form a committee. We have a lot of issues to work through to get this done. Village Manager has a template on the Village website of a letter to send to our Federal Representatives in Washington DC. Funds are supposed to be ear marked under the 2021 Infrastructure Bill. We are waiting to meet with the Army Corp of Engineers representative to hear how much is available.

Trustee Claudia Ressel-Hodan – I felt the Council had a good work session on December 20<sup>th</sup>. I would like to see us put into action many of the ideas and develop a Strategic Plan moving forward.
